1. The thesis project,
2. A portfolio explaining the professional practice. It can contain photos, drawings, etc. For the mention Practice and Theory of literary writing, they may be relevant excerpts from the candidate's works. Websites are accepted, url links must be communicated in the portfolio.

The portfolio is limited to 5 (five) pages.

For the Arts category, the size of the document is not limited.

3. A document "Annex" containing the applicant's CV of maximum 5 (five) pages and any supporting documents.
